

GUIDE FOR WRITING A RESUME

Step 1:

Insert your full name, address and contact information such as your email, telephone number etc.

Step 2:

Outline your main objective in one sentence. For example, "To obtain a position that may grant me the opportunity to contribute to your organization".

Step 3:

Outline your level of education (your degrees, certifications, subjects..)

Step 4:

List your work history if you do have such, beginning with the present or most recent work experience. For eg:

July 19, 2019 to Present: Programme Manager at Haven's Electronics

Step 5:

Add your hard and soft skills as well as your talents (strengths).

Step 6:

(Optional) Mention your interests/hobbies. This may include volunteerism, studying foreign languages, etc.

Step 7:

List two references, preferably one academic and one professional reference.

Step 8:

Review and proof read the resume in its entirety in order to check for errors.
